- (iii) engage in a short-term mentoring experience with an existing attorney-member, the scope and substance of which are subject to approval by the Board.
- 3. Attendance monthly meetings: a minimum of 4 monthly meetings each calendar year or 2 monthly meetings each calendar year if the member has also participated in two (2) collaborative team cases during each calendar year. A collaborative team case involves at least one (1) allied professional.
 - 4. Training: completion of 14 hour introductory training in collaborative law.
 - 5. Professional liability insurance with policy limits of no less than \$100,000/\$300,000.
